# **Political Recap**

On Mar. 18 Governor Hobbs vetoed HB 2570, dubbed the "starter home act", her second veto of the 2024 session. In her veto letter, the governor said the bill went too far and lacked the nuance necessary for statewide reform. The bill - backed by the Homebuilders Association and the Arizona Neighborhood Project - narrowly passed the House and Senate, with bipartisan opposition and support. Municipalities collectively opposed the measure. Governor Hobbs called on stakeholders to identify a compromise.

The Legislature has another vacancy after Representative Jevin Hodge (D-Tempe) resigned on Mar. 19. His resignation came after news reports on sexual misconduct violations while at George Washington University in 2015. Hodge was appointed to the House of Representatives in February to replace former Representative Athena Salman. Legislative District 8 Democrats will submit names for replacing Hodge to the Maricopa County Board of Supervisors.

Phoenix City Councilmember Yassamin Ansari <u>announced</u> she will resign from the council on Mar. 28 to run for Congress. Ansari is seeking to replace current Representative Ruben Gallego in CD 3, who is running for the U.S. Senate seat. Candidates seeking the appointment to replace Ansari on the council have until Apr. 9. Sitting councilmembers can nominate candidates for the appointment, who must then receive a majority of the council's vote to be appointed.

The City of Surprise unanimously voted down a proposed 475-unit townhome and commercial complex. Developers for the project collected more than 200 letters of support, but the council cited residents' opposition, increased traffic and the planning and zoning commission's recommendation to deny the application as the reason to vote in opposition. The council agreed with the commission that it was not the time for additional high density in the area.



The National Association of Manufacturers is suing the Environmental Protection Agency over the proposed particulate matter rule. The EPA is required to review the National Ambient Air Quality Standards (NAAQS) every five years. Maricopa County is facing serious consequences with the new particulate matter standards and will see a significant impact on manufacturing and development if action isn't taken by the EPA or Congress. **Arizona's Presidential Preference Election (PPE) was held on Mar. 19.** Both President Biden and Donald Trump were largely unopposed in their races. As of early reporting, Trump won 77.9% of Republican voters' support, while Nikki Haley - who suspended her campaign but remained on the ballot - received 18.7%. Biden received 89.5% of Democrats support with Marianne Williamson in second with 3.5%. Voter turnout for the PPE was roughly 37%.



# Legislature Takes Aim at the Arizona Commerce Authority

Senator Jake Hoffman (R-Queen Creek) has introduced an amendment to drastically reshape and reduce scope of the Arizona Commerce Authority. The bill would also eliminate the Arizona Competes Fund, the Research and Development Tax Credit, and removes the income tax subtraction for net capital gains derived from investment in a qualified small business.

NAIOP Arizona opposes the amendment and is working with stakeholders, policymakers and the business community to support the continuation of the Arizona Commerce Authority without punitive restrictions.



## Senate Finance Committee to Consider GPLET Reduction

HB 2309 (GPLET; agreement posting; abatement period) is set to be considered by the full Senate and potentially make it onto the Governor's desk by next week. The bill would effectively eliminate the GPLET program, one of the few development incentives available in Arizona. Reach out to your state senator and urge them to vote NO on HB 2309.

### **Water Policy**

In a surprise move, <u>HB 2008</u> (commercial; industrial; conservation requirements; rules), was amended in the Senate Natural Resources, Energy & Water Committee and received a 6-0 vote. The amendment removes the prohibition of requiring assured water supply for commercial and industrial development. NAIOP's Water Policy Task Force met again in March to discuss the legislation and other proposals with the goal of identifying improvements to Arizona's water policy that truly conserve and manage water better and are economically feasible.






# **Housing & Zoning**

**HB 2297 (adaptive reuse; commercial buildings; zoning)** passed out the Senate Finance & Commerce Committee in a 4-0 vote. The bill was amended to specify objective standards for municipalities to use for qualifying redevelopment, including adequate utility capacity, compliance with building and fire codes, and that existing buildings are functionally or economically obsolete. The League of Arizona Cities and Towns is now in support of the legislation.

**HB 2518 (municipalities; housing needs assessment; zoning)** failed to get heard in the Senate, meaning the bill is dead for this legislative session. However, proponents have amended the text of the bill to SB 1162, which was then passed out of the House Commerce Committee. The legislation creates requirements for municipalities to administratively review and make final decisions on zoning applications.

**HB 2734 (public hearings; voting)** passed out of Senate Finance & Commerce with a 3-2 vote. The bill requires municipalities to have no more than two public hearings for zoning ordinances. Members on the committee expressed concerns with the bill focusing on number of hearings rather than a timeline. The bill's fate is uncertain as it goes to the full Senate.





# Salt River Project Board Election

The Salt River Project (SRP) Board election is on Apr. 2, 2024. If you're a property owner in the SRP service territory you can vote in the upcoming SRP Board election.

Why this matters to your business: Environmental activists are pushing to elect SRP board members who will require the utility to meet high solar energy requirements that will put stability of the grid at risk. We may lose the competitive advantage of attracting tenants and investors that rely on stable power for their properties.
